## **EXECUTIVE DIRECTOR'S ACTIVITY STATEMENT**

As restrictions are lifting around the world the organization is looking forward as communities return to competitions with 145 held in 2021 and another 46 scheduled for the rest of the year.

The Board looks forward to a successful 2022 with the hopeful addition of having a continental championship on all 6 continents for the first time along with the world championship to be hosted in Korea in 2023.

## **FINANCIAL REPORT FOR 2020**

The treasurer was invited to present the financial report of the organization for the 2020 fiscal year. He noted due to a decrease in competitions the organization suffered a decrease in income.
